Amendment 3 Projects: Total Impact

Projects funded by Amendment 3 occur in four phases. Element 1 and Element 2 are completed with construction ending in 2008. The Element 3 phase began construction in 2006 and will end in 2011. Element 4 projects will occur between 2011-2013. Overall, Missouri's Statewide Amendment 3 projects invest over \$3.2 billion dollars in more than 367 transportation infrastructure projects across the state between fiscal years 2005-2013.

Over the life cycle of these projects, every dollar invested in Amendment 3 projects returns:

- \$0.08 in new net general revenues to the State of Missouri totaling \$242.2 million
- \$1.83 in new personal income to Missourians totaling \$5.9 billion
- \$3.23 in new value-added (GSP) to Missouri's economy totaling \$10.4 billion
- \$5.34 in new economic activity (output) to Missouri's economy totaling \$17.2 billion

On average, the project creates 7,576 new jobs annually paying an average wage of \$28,156 per job.
